Recipients of personal data

Data retention time

The period of data retention depends on the purpose of the processing. TGE will process personal data for as long as required for the specific purpose of the processing and in accordance with the applicable retention periods required under the respective legislation.

Rights of data subjects

Each person shall have the right to request access to, rectification, erasure, restriction of processing and the transfer of his or her personal data.

Every person has the right to object to the processing of personal data to the extent that the processing of personal takes place on the basis of a legitimate interest of the Controller.

Every person has the right to lodge a complaint against the processing of his/her data with the President of the Personal Data Protection Office.

Data source

Personal data may originate directly from data subjects, from Exchange/OTF Members or Exchange/OTF Member contractors, applicants for membership or other entities in accordance with the regulations prevailing at TGE.
