



## **Summary of trading activity at TGE in June 2025**

#### Press Release

- The volume of trading in gas forward contracts with physical delivery in June totalled nearly 22 TWh, as the upward trend observed in recent months continued. This is also the highest monthly result since September 2021 (23.2 TWh).
- The volume of trading in property rights for energy efficiency in June 2025 was higher by 19.6 per cent comparing to June of the past year, reaching 20 ktoe.

#### **Electricity**

In June 2025, the volume of electricity traded at TGE totalled 8,389,450 MWh, which represents a decrease by 31.9 per cent comparing to June 2024. The volume-weighted average price on the Day-Ahead Market was 350.58 PLN/MWh, going down by 65.70 PLN/MWh comparing to the month of May. On the EFM, the weighted average price of a yearly contract with base load delivery in 2026 (BASE\_Y-26) amounted to 419.47 PLN/MWh, up by 6.72 PLN/MWh over the corresponding price of such contract in the preceding month.

#### Natural gas

The volume of transactions concluded on the natural gas market in June 2025 totalled 23,841,133 MWh, an increase by 77.4 per cent y/y. The volume-weighted average price on the DAM&IDMg was 177.56 PLN/MWh, 10.57 PLN/MWh over the previous month's level. Meanwhile, on the GFM, the weighted average price of a contract with delivery in 2026 (GAS\_BASE\_Y-26) fell to 170.42 PLN/MWh in June, 0.96 PLN/MWh below the corresponding price of this contract in May.

## **Property rights**

The trading volume of property rights for electricity generated in RES totalled 1,155,138 MWh in June, going down by 30.1 per cent y/y. The volume-weighted average price of the PMOZE\_A instrument traded during the PRM sessions was 26.05 PLN/MWh and was lower by 2.44 PLN/MWh than in May 2025.

The volume of trading in property rights for energy efficiency went up by 19.6 per cent y/y, to 20,054 toe. The weighted average session price of PMEF\_F instrument was 2,393.22 PLN/toe going up by 65.83 PLN/toe as compared to May.

#### **Guarantees of origin**

The volume of guarantees of origin for electricity generated in RES traded in June totalled 2,975,201 MWh falling by 22.8 per cent y/y. The weighted average price of a guarantee of electricity generated in RES was 4.89 PLN/MWh, and was higher by 1.11 PLN/MWh than in the previous month.

### **Agri-food commodities**

No transactions were made on the Exchange Agricultural Market in June 2025.
